Issues planned by the Federal government in the fourth quarter 2024

The Federal government's issuance plan for the fourth quarter of 2024 has been adjusted as follows compared to the annual forecast published in December 2023:

- The issue of a Green Federal security announced for 5 November 2024 is cancelled.
 The issuance of Green Federal securities with a total volume of €17 billion to €19 billion is planned for this year; this will be achieved with the issuance on 8 October 2024.
- On the money market, €2 billion less will be raised than announced in December 2023. The volume of the planned increases of Treasury discount paper with a remaining term of eleven months on 21 October 2024 and 11 November 2024 will be reduced by €1 billion each to €2 billion each.

For the multi-ISIN auctions in the 15- and 30-year maturity segment announced in the fourth quarter, the benchmark bonds to be tapped are specified in Annex 1. The second Federal security for the respective multi-ISIN auction will be announced in the week before the corresponding issue. The green issue in October will also be specified in the week prior to the issue date stated in Annex 1.

The annual issuance preview for 2025 will be published in December 2024.
