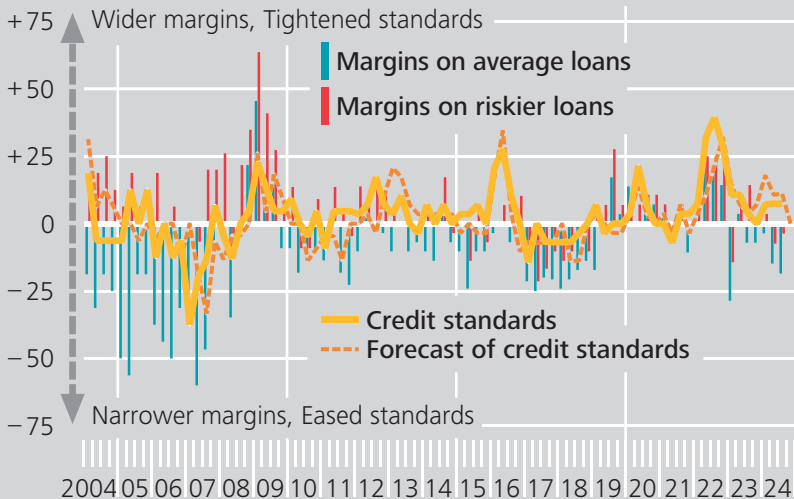


Changes in credit standards and interest margins* on loans to households for house purchase in Germany
