## Auction announcement

## Treasury discount paper (Unverzinsliche Schatzanweisungen – "Bubills") of the Federal Republic of Germany

As already announced in the issuance calendar for the fourth quarter of 2013, the Federal Government will issue Treasury discount paper ("Bubills") with a maturity of 6 months for sale by auction on 14 October 2013. An issue volume (auction allotment and amount set aside for secondary market operations) of  $\in$ 3 billion is envisaged. Members of the Bund Issues Auction Group are entitled to bid.
