### **Auction announcement Reopening of five-year Federal notes (Bundesobligationen – “Bobs”) series 170 by auction**

As already announced in the issue calendar for the fourth quarter of 2014, the Federal Government will reopen once again the

on 3 December 2014, using an auction procedure. An increase of €3 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of this series amounts to €13 billion. Members of the Bund Issues Auction Group are entitled to bid.
