Auction announcement

Treasury discount paper (Unverzinsliche Schatzanweisungen – "Bubills") of the Federal Republic of Germany

As already announced in the issuance calendar for the second quarter of 2016, the Federal Government will issue Treasury discount paper ("Bubills") with a maturity of 12 months for sale by auction on 25 April 2016. An issue volume (auction allotment and amount set aside for secondary market operations) of €1.5 billion is envisaged. Members of the Bund Issues Auction Group are entitled to bid.

Time schedule of the auction procedure:

Date of invitation to bid: Friday, 22 April 2016
Bidding period: Monday, 25 April 2016,

from 8.00 a.m. until 11.30 a.m. Frankfurt time

Value date: Wednesday, 27 April 2016
