## Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the second quarter of 2016, the Federal Government will reopen once again the

## 0.50 % bond of the Federal Republic of Germany of 2016 (2026)

issued on 13 January 2016 - ISIN DE0001102390

on 18 May 2016, using an auction procedure. An increase of €4 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to €18 billion. Members of the Bund Issues Auction Group are entitled to bid.
