Auction announcement

Treasury discount paper (Unverzinsliche Schatzanweisungen – “Bubills”) of the Federal Republic of Germany

As already announced in the issuance calendar for the first quarter of 2017, the Federal Government will issue Treasury discount paper (“Bubills”) with a maturity of 6 months for sale by auction on 13 March 2017. An issue volume (auction allotment and amount set aside for secondary market operations) of € 2 billion is envisaged. Members of the Bund Issues Auction Group are entitled to bid.

Bidding period:	Monday, 13 March 2017, from 8.00 a.m. until 11.30 a.m. Frankfurt time
Value date:	Wednesday, 15 March 2017
