Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the fourth quarter of 2017, the Federal Government will reopen once again the

0.50 % bond of the Federal Republic of Germany of 2017 (2027)
issued on 12 July 2017 - ISIN DE0001102424

on 25 October 2017, using an auction procedure. An increase of € 3 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to € 17 billion. Members of the Bund Issues Auction Group are entitled to bid.

Bidding period:	Wednesday, 25 October 2017, from 8.00 a.m. until 11.30 a.m. Frankfurt time

Maturity:	15 August 2027
Interest payment:	15 August annually, interest has begun to accrue on 14 July 2017
First interest payment:	15 August 2018 for 397 days
