1 Introduction

In the electronic reporting system XMW, reports can be submitted to the Deutsche Bundesbank in XML format.

This document describes the XML format to be used for submitting reports for the statistics on investment funds to the Deutsche Bundesbank.

2 Submission method

The monthly report for the statistics on investment funds is submitted as an XML file via the Bundesbank's ExtraNet.

2.1 BBk ExtraNet

2.2 XML

XML (= "eXtensible Markup Language") is the industry standard for defining documents with hierarchically structured content. It allows the definition of elements and attributes. Elements are basic modules and are composed recursively of data and other elements. An element consists of a start tag `<elementname>`, the element content and an end tag `</elementname>`. In the start tag, attributes can be added to the element using the following syntax: `attributname="attribut"`. Each XML document has a tree structure with a unique root element.

Example

XML is case-sensitive, ie it distinguishes between upper and lower case.

XML files are pure text files. Their file extension is ".xml".

2.3 Validation

An XML schema describes the layout of elements, their form (numbers, text, ...) and their attributes. An XML file is termed "valid" if it conforms to your schema. An XML file can be validated using standard tools.

3 Reporting file

3.1 File name

The file name of the XML file to be submitted comprises the identification for the statistics on investment funds (= InvV), the reporting month, the 5-digit BBk institution ID and a serial number. It is

invv_yyyymm_instid_lfnr.xml

Parameter	Contents
invv	Abbreviation for the statistics on investment funds
<i>yyymm</i>	Reporting month with the year as four digits and month as two digits
<i>instid</i>	5-digit BBk institution ID of reporting company
<i>lfnr</i>	2-digit serial number begins again in each new reporting month with "01"

Example: **invv_201412_00123_01.xml**

Several XML files (with correct names) can be combined in one ZIP file. The resulting ZIP file is named according to the same principle as the XML file (without a serial number). The extension is ".zip".

Example: **invv_201412_00123.zip**

Correction reports are to be identified in the file name.

Example: **invv_201412_00123_01_korrektur.xml**
 invv_201412_00123_korrektur.zip

The file name for test files must begin with "TEST_", both in ZIP and XML files. It does not matter whether the text is in upper or lower case.

Example: **TEST_invv_201412_00123_01.xml**
 test_invv_201412_00123.zip

3.2 File format

Report files are coded in XML.

As an aid for creating the file, XML schemas are available for download from the Bundesbank's website at

http://www.bundesbank.de/Navigation/DE/Service/Meldewesen/Bankenstatistik/Formate_XML/formate_xml.html.

To ensure data integrity, we recommend validating the generated XML files using the schema definitions.

BbkXmwBasis.xsd	Basic schema for XML reports to the Bundesbank

3.2.1 Notation

XML is case-sensitive. In the Bundesbank's XML reporting system, the names of elements are usually written in upper-case letters, and those of attributes in lower-case letters. If different elements are located at the same hierarchical level, the sequence of elements is generally the determining factor. The sequence of attributes is arbitrary.

3.2.2 Character set

The character set is Latin-1/West European (ISO-8859-1). This ensures, among other things, that umlauts are displayed correctly.

The ampersand ("&") is not permissible. However, if it is needed, for instance in the name of a bank, then it should be replaced with "&".

Example: "Mark & Meier Bank" → "Mark & Meier Bank"

The less-than sign ("<") is also not permissible. However, if it is needed, then it should be replaced with "<" (or written in full).

Example: "If reporting date < 01-01-2014, then..." → "If reporting date < 01-01-2014, then..."

3.2.3 XML declaration

Each XML report begins with the XML declaration

<?xml version="1.0" encoding="ISO-8859-1"?>
```

which must always appear in the first line.

3.2.4 Name spaces

To differentiate the Bundesbank's general XMW schema (BbkXmwBasis.xsd) from the specific InvV schema (BbkXmwInvv_2015.xsd), the following name spaces are used:

Name	Name space

In the examples, the InvV name space is used as the standard name space, ie the elements of this name space do not require any qualification. For the general XMW name space, the abbreviation bbk is used, ie all elements from this name space must be qualified with "bbk:".

3.3 Element descriptions

The following table describes the elements.

Name	Req (= required)	Value range / format	Comments

* **If an element is to be omitted, then it should be eliminated in its entirety and not just its contents.**

3.4 Data types

The XMW schema definitions use self-defined elements and data types. They are described below.

3.4.1 Elements

I General schema

bbk:ISIN

12-digit securities identification number in ISIN format

The ISIN consists of 12 alphanumeric characters (upper-case letters and/or numbers). The first two characters are always upper-case letters (country identification), while the remaining 10 characters are made up of upper-case letters and numbers.

II InvV schema

BBK_INSTITUTS_ID

BBk institution ID

The Bundesbank assigns an institution ID to the reporting company. It is a 5-digit alphanumeric ID and for those companies that are already registered, it comprises the previous KAG number with preceding zeros.

The Bundesbank also assigns the required institution ID for third parties that are contracted by a company to submit the reports.

The institution ID (BBK_INSTITUTS_ID) on the templates must be identical to the BBK_INSTITUTS_ID of the element MELDER (REPORTER).

BIC

Business identifier code

The business identifier code (BIC) consists of at least 8 and no more than 11 numbers or upper-case letters.

LEI

Legal entity identifier

The legal entity identifier (LEI) is based on the ISO standard 17442 and consists of 20 alphanumeric characters.

INTERNE_KNR

Internal ID number

The internal ID number of investment funds without an ISIN for which a report is to be submitted or of held securities without an ISIN consists of 12 alphanumeric characters (upper-case letters and/or numbers).

For closed investment funds, the internal ID number corresponds to the BBK_INSTITUTS_ID with the preceding zeros.

3.4.2 Simple data types

I General schema

bbk:alphanum

1 to 80 characters, alphanumeric

The alphanum data type is used for text content, eg for name fields. Data of this type may be up to **80 characters** in length, but may **not be blank**. Only upper-case letters may be used. All characters of the ISO 8859-1 character set are permitted ("&" is to be replaced with "&" and "<" with "<"). Multiple spaces, tabs and line breaks are reduced to a single space during editing.

bbk:email

Valid e-mail address

A valid e-mail address takes the form: "characterstring@characterstring.do" (do = 2 to 4-digit domain name). A personal or functional address can be entered.

bbk:isoLand

ISO country code

ISO 3166 assigns every country a code consisting of two upper-case letters, eg "DE" for Germany. One number and one upper-case letter is permissible for international organisations, eg "1Z" for the United Nations.

bbk:isoWaehrung

ISO currency code

ISO 4217 assigns every currency a code consisting of three upper-case letters, eg "EUR" for euro.

bbk:jaNein

"yes" or "no"

The entry "yes" or "no" must always be written in lower case.

bbk:telNr

Valid telephone number format

A valid telephone number consists of a sequence of digits. The area code is optional and can be denoted by "(" or "/", and the extension can be introduced with "-". Spaces can be used to structure the number.

II InvV schema

text40

Maximum of 40 characters of alphanumeric text.

text150_NonEmptyString

Maximum of 150 characters of alphanumeric text. Element cannot be left empty.

betrag12

12digit amount

betrag12 specifies a number or amount in thousands of euro without any decimal places and comprising up to 12 digits. The amount is to be stated either in full without spaces or right-justified with preceding zeros or spaces.

Negative amounts have a minus sign ("-") in front of the first number. The number of digits is **not increased** by this (no more than 11 digits and one "-").

Commas, full stops and other separators are not permissible.

Examples

123456789012
123435
000012345678
-12345678901

betragglz

20-digit amount as floating point number:

betragglz specifies a number comprising up to 20 digits. The position of the decimal comma is not fixed and may be omitted. If the amount has a decimal point, however, at least one number must be before and after it. The entire length of the number may not exceed 20 digits, including the point. The amount is to be provided either in full without spaces or right-justified with preceding zeros or spaces.

Negative amounts have a minus sign ("-") in front of the first number. This does **not increase** the number of digits (no more than 19 digits and one "-" or no more than 18 digits and one comma and one "-").

Points and other separators are not permitted.

date_nicht_vorhanden

Consists of xs:date and "not available".

3.4.3 Complex data types

I General schema

bbk:adresse

The bbk:adresse data type standardises the form of companies' address data. It is used in the bbk:ERSTELLER (CREATOR), bbk:ADRESSAT (ADDRESSEES), bbk:ABSENDER (SENDER), bbk:MELDER (REPORTER) elements and contains the following sub-elements.

It is essential to enter the optional elements in bbk:MELDER (REPORTER), bbk:ABSENDER (SENDER) and bbk:ERSTELLER (CREATOR) to ensure smooth processing within the Bundesbank.

4 InvV report

4.1 XML report structure

All XML banking statistics files have a common, basic hierarchical structure. It begins with a root element with address information (LIEFERUNG-INVV (DELIVERY)). It contains a reporting element (MELDUNG (REPORTING)) which, in turn, contains form elements. The form elements (InvV forms) contain reporting data at the lowest level of detail.

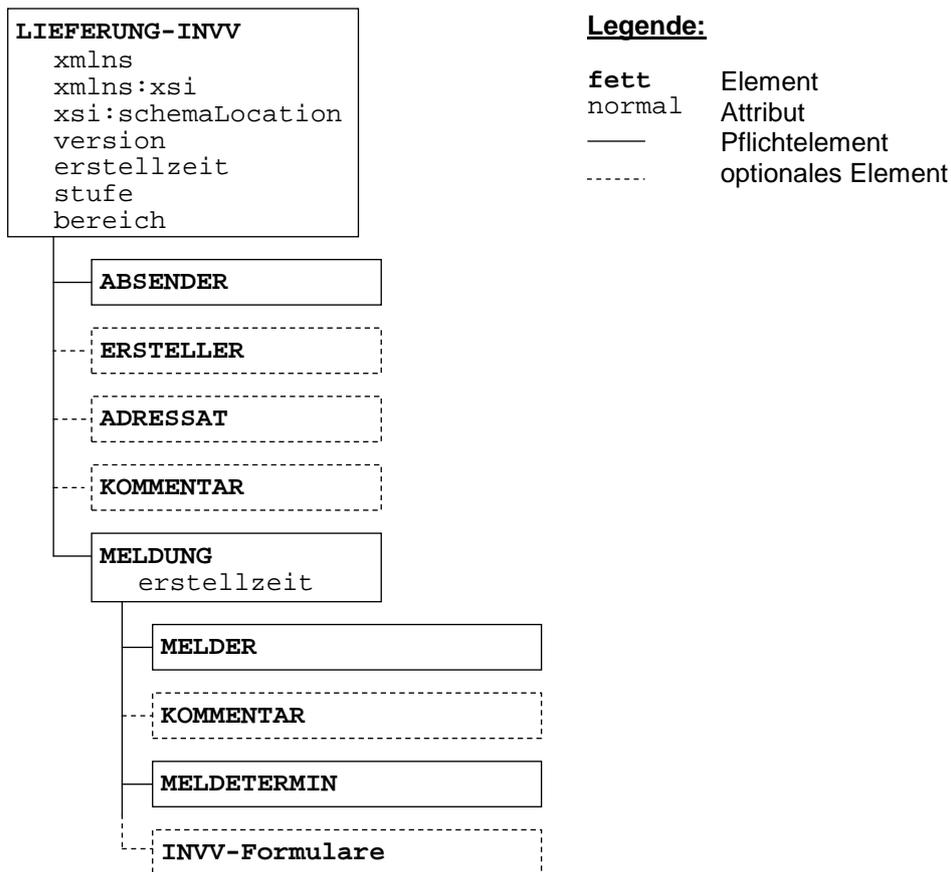

The `bbk:ABSENDER` element is of the `bbk:adresse` data type. The contents include address information on the company that submitted the XML file. The first sub-element is `BBK_INSTITUTS_ID`; this is where the institution ID that the Bundesbank assigned to the reporting company should be entered.

The `bbk:ERSTELLER` element is optional and of the `bbk:adresse` data type. It contains address information on the party creating the XML report if s/he is not identical to the sender.

The `bbk:ADRESSAT` element is optional and of the `bbk:adresse` data type. As a general rule, it is not used for reports submitted to the Deutsche Bundesbank; it is intended for use when exchanging data with third parties.

The optional `bbk:KOMMENTAR` element is irrelevant for statistics on investment funds.

The `MELDUNG` element is mandatory and may appear several times. It contains the report forms for statistics on investment funds.

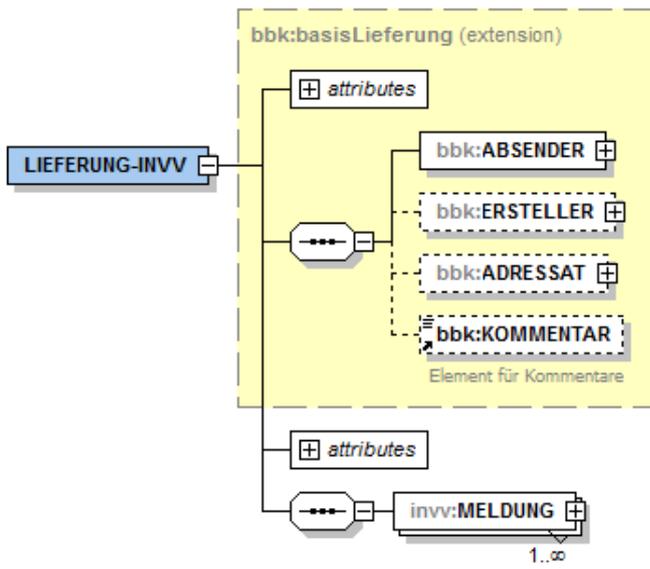
