Announcement of auction Reopening 30-year Federal bond

As already announced in the issuance calendar for the second quarter of 2021, the Federal Government will reopen once again the

0 % bond of the Federal Republic of Germany of 2019 (2050)
issued on 21 August 2019 - ISIN DE0001102481

on 9 June 2021, using an auction procedure. An increase of € 1.5 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to € 26.5 billion. Members of the Bund Issues Auction Group are entitled to bid.

from 8.00 a.m. until 11.30 a.m. Frankfurt time
