Issue of Federal Treasury notes

- Announcement of auction -

As already announced in the issuance calendar for the second quarter of 2020, the Federal Government will issue two-year Federal Treasury notes by auction on 26 May 2020. An issue volume (auction allotment retention quote) of €5 billion is being envisaged. Members of the Bund Issues Auction Group are entitled to bid.

Bidding period: Tuesday, 26 May 2020,

from 8.00 a.m. until 11.30 a.m. Frankfurt time

Stock exchange listing: Tuesday, 26 May 2020

Interest payment: annually on 10 June,
