## Announcement of auction Reopening 30-year Federal bond

As already announced in the issuance calendar for the fourth quarter of 2020, the Federal Government will reopen once again the

## 0 % bond of the Federal Republic of Germany of 2019 (2050)

issued on 21 August 2019 - ISIN DE0001102481

on 11 November 2020, using an auction procedure. An increase of €1 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to €16.5 billion. Members of the Bund Issues Auction Group are entitled to bid.
