## Announcement Federal Treasury discount paper (Bubills)

According to the issuance schedule of the German Federal Government for the first quarter of 2021 the following Bubills will be reopened by a multi-ISIN auction on 1 February 2021:

Reopening Federal Treasury discount paper (Bubills) May 2020 issue / maturity 12 months ISIN DE0001030211 Current volume: €13.5 billion Due on 5 May 2021 Residual maturity: 3 months (91 interest days)

Reopening Federal Treasury discount paper (Bubills) November 2020 issue / maturity 12 months ISIN DE0001030278 Current volume : €2 billion Due on 24 November 2021 Residual maturity: 9 months (294 interest days)

A total amount of  $\in 6$  billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of  $\in 3$  billion for each Bubill. The effective increase amount of each Bubill will be determined as part of the auction allotment on 1 February 2021.

Members of the Bund Issues Auction Group are entitled to bid. Bids are to be submitted through the Bund Bidding System BBS and must be for a par value of not less than €1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.00005 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the bids accepted. The right to scale down bids is reserved.
