Announcement Federal Treasury discount paper (Bubills)

According to the issuance schedule of the German Federal Government for the fourth quarter of 2021 the following Bubills will be reopened by a multi-ISIN auction on 15 November 2021:

Reopening Federal Treasury discount paper (Bubills) April 2021 issue / maturity 12 months ISIN DE0001030369 Current volume : € 14 billion Due on 21 April 2022 Residual maturity: 5 months (155 interest days)

Reopening Federal Treasury discount paper (Bubills) October 2021 issue / maturity 12 months ISIN DE0001030427 Current volume : € 4 billion Due on 19 October 2022 Residual maturity: 11 months (336 interest days)

A total amount of \in 6 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of \in 3 billion for each Bubill. The effective increase amount of each Bubill will be determined as part of the auction allotment on 15 November 2021.

Members of the Bund Issues Auction Group are entitled to bid. Bids are to be submitted through the Bund Bidding System BBS and must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.00005 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the bids accepted. The right to scale down bids is reserved.
