Announcement of auction New 15-year Federal bond issue

As already announced in the issuance calendar for the second quarter of 2022, the Federal Government will launch a new bond issue (maturity: 15 May 2038) by auction on 27 April 2022. An issue volume (auction allotment and retention quote) of € 2 billion is envisaged. Members of the Bund Issues Auction Group are entitled to bid.

Time schedule of the auction procedure:

Date of invitation to bid:	Tuesday, 26 April 2022
Bidding period:	Wednesday, 27 April 2022 from 8.00 a.m. until 11.30 a.m. Frankfurt time
Stock exchange listing:	Wednesday, 27 April 2022
Value date:	Friday, 29 April 2022

Characteristics of the Federal bond:

Maturity:	15 May 2038
Interest payment:	annually on 15 May, interest begins to accrue as of 29 April 2022
First interest payment:	15 May 2023 for 381 days
ISIN	DE0001102598

The nominal interest rate of the Federal bond will be published on the date of invitation to bid. In case of a nominal interest rate higher than zero the separate trading of registered interest and principal („stripping“) will be possible.
