## Invitation to bid Federal Treasury discount paper (Bubills)

As already announced the following Bubills will be reopened by a multi-ISIN auction on 25 July 2022:

Reopening Federal Treasury discount paper (Bubills) December 2021 issue / maturity 12 months ISIN DE0001030443 Current volume : € 12 billion Due on 14 December 2022 Residual maturity: 5 months (140 interest days)

Reopening Federal Treasury discount paper (Bubills) June 2022 issue / maturity 12 months ISIN DE0001030856 Current volume : € 3 billion Due on 21 June 2023 Residual maturity: 11 months (329 interest days)

A total amount of  $\in$  6 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of  $\in$  3 billion for each Bubill. The effective increase amount of each Bubill will be determined as part of the auction allotment on 25 July 2022.

The price bids must be expressed as full 0.00005 percentage points. It is possible to make non-competitive bids and to submit several bids at different prices. No yield bids will be considered. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the price bids accepted. The right to scale down bids is reserved.
