## Announcement Federal Treasury discount paper (Bubills)

According to the issuance schedule of the German Federal Government for the third quarter of 2022 the following Bubills will be reopened by a multi-ISIN auction on 5 September 2022:

Reopening Federal Treasury discount paper (Bubills) December 2021 issue / maturity 12 months ISIN DE0001030443 Current volume : € 15 billion Due on 14 December 2022 Residual maturity: 3 months (98 interest days)

Reopening Federal Treasury discount paper (Bubills) June 2022 issue / maturity 12 months ISIN DE0001030856 Current volume : € 6 billion Due on 21 June 2023 Residual maturity: 9 months (287 interest days)

A total amount of  $\in$  5 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of  $\in$  3 billion for the Bubill December 2021 issue (ISIN DE0001030443) and  $\in$  2 billion for the Bubill June 2022 issue (ISIN DE0001030856). The effective increase amount of each Bubill will be determined as part of the auction allotment on 5 September 2022.

Members of the Bund Issues Auction Group are entitled to bid. Bids are to be submitted through the Bund Bidding System BBS and must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.00005 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the bids accepted. The right to scale down bids is reserved.
