Announcement of a multi-ISIN auction Reopening of two Federal bonds

On 12 April 2023 the following Federal bonds will be reopened by a multi-ISIN auction:

1.25 % bond of the Federal Republic of Germany of 2017 (2048)

ISIN DE0001102432

Maturity: 15 August 2048

Current volume : € 35.5 billion

0 % bond of the Federal Republic of Germany of 2021 (2052)

ISIN DE0001102572

Maturity: 15 August 2052

Current volume : € 20.5 billion

An increase of € 2.5 billion in total is envisaged for the reopening of both bonds (including respective retention quote) with a planned share of € 1 billion for the 1.25 % bond of the Federal Republic of Germany of 2017 (2048), ISIN DE0001102432, and € 1.5 billion for the 0 % bond of the Federal Republic of Germany of 2021 (2052), ISIN DE0001102572. The effective increase of each bond will be determined by the allotment on 12 April 2023.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.01 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the competitive bids accepted. The right to scale down bids is reserved.

In addition, the Auction rules, the Special terms and conditions of the Deutsche Bundesbank for auctions of Federal securities using the Bund Bidding System (BBS) and the issuance terms and conditions of the initial issuance shall apply.
