Announcement of auction Reopening of Federal Treasury notes

As already announced in the issuance calendar for the second quarter of 2023, the Federal Government will reopen the

2.80 % Federal Treasury notes of 2023 (2025)

due on 12 June 2025 issued on 25 April 2023 - ISIN DE000BU22015

by auction on 23 May 2023. An increase of € 6 billion is envisaged for the issue (auction allotment and retention quote). The current volume amounts to € 6 billion. Members of the Bund Issues Auction Group are entitled to bid.
