1. Introduction

ECMS go-live is currently foreseen for 08th April, 2024. Every counterparty that maintains a collateral account with the Deutsche Bundesbank after ECMS has been put into operation is obliged to send a registration form¹ for the ECMS production environment to the Bundesbank's ECMS migration team. The registration form is used to enter the counterparty-specific data in the ECMS production environment. You only need to complete the counterparty-specific data that the Bundesbank currently does not have. The reference data is set up accordingly by the Deutsche Bundesbank. There are no further activities needed on your side, except for the creation of additional users in the ECMS production environment. The registration forms and fill-in guidance are sent to the counterparties via e-mail and are made available on the Website of the Bundesbank.

2. Procedure

Please send the completed Excel file in .xlsx-format to the following e-mail address:

The additional sending of a signed PDF version is not required.

A total of four different registration forms for the ECMS production environment are available:

- 1. Banks with own access and the creation of two user administrators per institution
- 2. Banks with own access and the creation of one user administrator per institution
- 3. Banks with a service provider and the creation of two user administrators per institution
- 4. Banks with a service provider and the creation of one user administrator per institution

If your institution uses network access to ECMS via a third party, please instruct your third party to return the Service Provider form (3./4.) for you.

If your institution plans to close its collateral account until ECMS is operational, we ask you to inform Deutsche Bundesbank as soon as possible about this decision. If you are planning a merger with another institution that will be finished before the start of production, only the acquiring institution has to submit a registration form. In this case, we would nonetheless ask both the acquired institution and the acquiring institution to provide us with additional information on the merger via e-mail.

It is essential that the registration form and the additional information are returned via e-mail to the ecms-migration@bundesbank.de e-mail address by 15/08/2023. If you do not submit a registration form until the above mentioned date, Deutsche Bundesbank cannot guarantee that your institution will have access to ECMS after production went live.

3. General Information

The registration form is used to create the initial load of reference data in the ECMS production environment. In the event of changes or deletions after the initial creation of the reference data, please send us the original registration form highlighting the changes. No field validators are stored in the form.

Characters outside the permitted CRDM character set may not be used in the form. These especially include mutations (ä, ö, ü) and "ß" (exception: e-mail addresses).

The form consists of an Excel file with a single tab. In the following the fields are described in more detail.

The column notations highlighted in blue in the Excel file contain the name of the respective data group. All data entry fields highlighted in white are editable and have to be completed (exception: technical addresses and A2A counterparty users; for details see section 4.2). The orange-coloured fields cannot be edited. The RIAD code only has to be entered once in the first dedicated RIAD-input field. The other orange-coloured data fields with RIAD codes are then automatically completed with the respective RIAD code.

4.2.4. U2A counterparty administrator user

Users already set up in TARGET Services T2S, TIPS or T2 <u>cannot</u> be automatically used for ECMS; they must be set up and approved separately inside ECMS. The users requested for the UTEST/PreProd ECMS environment are likewise not automatically set up by the Deutsche Bundesbank in the ECMS production environment. The creation of the user administrators for the ECMS Production environment must be requested explicitly in the ECMS production registration form.

The Bundesbank creates a maximum of two U2A users per institution (user administrators). If required, each user administrator can set up additional ECMS users (possibly also other user administrators) for the institution itself. In addition, user administrators can assign themselves and the users of their institution additional roles or withdraw roles. It is not possible to change or edit in CRDM, because ECMS has a separate role and rights system. To be able to create additional administrators, the following roles must be assigned to them:

- ECMS ENTITY U2A ADMINISTRATOR EXECUTION #54
- Super Validator (administrator is allowed to act according to the two-eyes principle) or Validator (administrator must act according to the four-eyes principle)

Furthermore, the user administrators created by the Deutsche Bundesbank do not have any additional rights. Additional rights can be assigned to the administrators by themselves at any time (possibly in the four-eyes principle).

A description of the roles and respective rights can be found in the document "U2A and A2A roles in the ECMS" and in the Access Rights matrix. Both documents are available on the ECB's website:

Access rights matrix for ECMS

The creation and processing of ECMS users and user administrators can be found in the "Reference Data" module or the following menu item:

Reference Data → Access Right Reference Data → Users Create / Display

If only one user administrator is to be created by the Bundesbank in the production environment, the required roles for exercising them according to the two-eyes principle will also be assigned by the Bundesbank. The two-eyes principle allows entries and changes to be made in ECMS without the need for approval by another user or user administrator. If two user administrators are set up by the Bundesbank, they are automatically assigned with roles requiring the four-eyes principle.

Please note: For the moment being, the users and user administrators in the UTEST/PreProd environment will be created with two-eyes principle as the four-eyes principle is not yet available for testing.

4.2.5. Banking Group

The Banking Group allows the Banking Group Manager to look at several parties belonging to their institution or group. The Banking Group Manager can view information on the collateral pools of the assigned members of the Banking Group.² For ECMS, the banking groups already applied for the other target services (T2, tips, T2S) can be reused. Please note that the information on the banking group in the ECMS production registration form is used exclusively for setting up in ECMS. Please contact the responsible office for any changes to the banking group information in other TARGET Services (T2, TIPS, T2S).

A new banking group in ECMS can be applied for at the Central Bank of the Banking Group Manager. The name of the banking group is then to be passed on within the institution or group and forwarded to the Central Banks of the banking group members. The relevant Central Banks will then ensure that the Banking Group members are added to the Banking Group in ECMS.
