# Announcement of auction Reopening of Federal Treasury notes

As already announced in the issuance calendar for the first quarter of 2024, the Federal Government will reopen once again the

**2.50 % Federal Treasury notes of 2024 (2026)**  
due on 19 March 2026  
issued on 30 January 2024 - ISIN DE000BU22049

by auction on 12 March 2024. An increase of € 4.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume amounts to € 10 billion. Members of the Bund Issues Auction Group are entitled to bid.
