Invitation to bid Federal Treasury discount paper (Bubills)

As already announced the following Bubills will be reopened by a multi-ISIN auction on 26 August 2024:

> Reopening Federal Treasury discount paper (Bubills) January 2024 issue / maturity 12 months ISIN DE000BU0E139 Current volume : € 11 billion Due on 15 January 2025 Residual maturity: 5 months (140 interest days)

Reopening Federal Treasury discount paper (Bubills) July 2024 issue / maturity 12 months ISIN DE000BU0E196 Current volume : € 3 billion Due on 16 July 2025 Residual maturity: 11 months (322 interest days)

A total amount of € 6 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of € 3 billion for the Bubill January 2024 issue (ISIN DE000BU0E139) and € 3 billion for the Bubill July 2024 issue (ISIN DE000BU0E196). The effective increase amount of each Bubill will be determined as part of the auction allotment on 26 August 2024.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than \in 1 million or an integral multiple thereof. The yield bids must be expressed as full 0.001 percentage points. It is possible to submit non-competitive bids and several bids at different yields. No price bids will be considered. The bids accepted by the issuer will be allotted at the yield specified in the bid. Non-competitive bids are filled at the weighted average yield of the competitive bids accepted. The right to scale down bids is reserved.

Settlement:	delivery versus payment-settlement in the night-time processing of Clearstream
