3.1 **DWH**

3.1.1 Activation of DWH reports

- CON02 and PAR06 will not be activated with T2 R2024.NOV in T2 PROD. It is foreseen to activate both reports with T2 R2025.JUN.

3.1.2 DWH Data Reload

*DWH Data Reload required

The recent updates in DWH contain modifications to the ETL (Extract, Transform, Load) process. These changes will be applied to new data upon the deployment, but will not retroactively correct historical data previously processed and stored using the flawed ETL.

Consequently, the efficacy of these updates can only be evaluated using data from business days following the deployment at first. Historical data will remain unchanged and should only be considered accurate if it was not affected by the ETL issues.

The reprocessing of the data is executed during the weekend after the deployment and ensures that data are reloaded and corrected as of **Monday**, **18.11.2024** after the deployment, so that also the previous data will be displayed correctly in the reports. In case of unforeseen events, which hamper the mentioned reprocessing during the weekend, 4CB will inform accordingly.

However, the reprocessing of the data for IDC and BPM reports is executed during the week and ensures that data are reloaded and corrected as of **Monday**, **25.11.2024**, so that also the previous data will be displayed correctly in the reports. Meanwhile, all these reports can be used with new data. In case of unforeseen events, which hamper the mentioned reprocessing during the weekend, 4CB will inform accordingly.

3.2 Regression risk

The regression risk for this release is considered low according to the non-regression tests performed.
