## Announcement of auction Reopening 10-year Federal bond

issued on 8 January 2025 - ISIN DE000BU2Z049

on 19 February 2025, using an auction procedure. An increase of € 4.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume of the bond amounts to € 9.5 billion. Members of the Bund Issues Auction Group are entitled to bid.
