1 Introduction

Using the XML-based electronic reporting system (*XML-basierten elektronischen Meldewesen* – XMW), reports can be submitted to the Deutsche Bundesbank in XML format.

This document describes the XML format used to submit reports for the statistics on investment funds to the Deutsche Bundesbank.

1.1 Changes as of the reporting month December 2025

The new ECB Regulation (EU) 2024/1988 introduces some changes to the existing XML reporting template from 2015. Here is a brief overview of the key changes:

- In the new template, the root element is named <LIEFERUNG-INVV2>.
- Forms 10389 and 10392 are no longer required, meaning that the reporting elements <ALLGEMEIN_GESSELLSCHAFT> and <BEREINIGUNGEN> are also no longer required.
- All euro amounts are to be stated in full euro (no longer in thousands of euro).
- In future, for the purposes of calculating adjustments, unique identifiers (“OBJEKTID”) must be used for some reporting items. These identifiers must be unique across all reporting months and must always be assigned to the same asset and liabilities position.
- To avoid duplicating information within an XML report file, unique keys have been assigned to identifiers.
- A period is used as the decimal separator, instead of a comma as was previously the case.

2 Submission method

The monthly report for the statistics on investment funds (*Statistik über Investmentvermögen* – InvV) must be submitted as an XML file via Bundesbank NExt.

3.2 File format

Report files must be submitted in XML format.

To assist in creating the file, XML documentation and example files are available for download from the Bundesbank's website.

To ensure data integrity, we recommend validating the generated XML files using the schema definitions:

3.2.1 Notation

XML is case-sensitive. In the Bundesbank's XML reporting system, the names of elements are usually written in upper case letters and those of attributes in lower case letters. If different elements are located at the same hierarchical level, the sequence of elements is generally the determining factor. The sequence of attributes is arbitrary.

3.2.2 Character set

The character encoding standard used is UTF-8 (recommended) or Latin-1/West European (ISO-8859-1). For free text fields, adherence to the DIN 91379 standard is mandatory, which is ensured by the XML schema.

3.2.3 Name spaces

To differentiate the Bundesbank's basic XMW schema (BbkXmwBasis.xsd) from the specific InvV schema (BbkXmwInvv_2026.xsd), the following namespaces are used:

In the examples, the InvV namespace is used as the standard namespace, i.e. the elements of this namespace do not require any qualification. For the general XMW namespace from the basic schema, the abbreviation “bbk” is used, i.e. all elements from this namespace must be qualified with “bbk”.

3.3 Element descriptions

Elements are described using the following table format:

3.4 Data types

The XMW schema definitions use self-defined elements and data types. These are described below.

3.4.1 Elements

InvV schema

BBK_INSTITUTS_ID

Bundesbank institution identification number:

The institution identification number is assigned to the reporting company by the Bundesbank. It is a five-digit number.

The Bundesbank also assigns the required institution ID to third parties that are contracted by a company to submit the reports.

INTERNAL_WP_KNR

Internal securities identification number:

The internal securities identification number is used to designate holdings of securities that do not have an ISIN, for which information should be provided in item 11 of the reporting form V10391.

The internal securities identification number is made up of 12 alphanumeric characters: upper case letters and/or numbers.

General schema

No elements from the general schema are used.

3.4.2 Simple data types

InvV schema

Technical, simple data types

Within the UTF-8 encoding approved for InvV in the XMW, encoding is restricted to the DIN 91379 standard. The following technical data types are defined for this purpose:

datatypeA

DIN 91379 data type A:

Data type A indicates which characters should be used for the names of natural persons.

datatypeA_1_80

DIN 91379 data type A with 1-80 characters

datatypeB

DIN 91379 data type B:

Data type B is used primarily for other names, such as town/city names and street names with house numbers.

datatypeB_1_80

DIN-91379 data type B with 1-80 characters

datatypeD

DIN 91379 data type D:

This data type can only be supported by IT procedures that also support the non-normative characters in the DIN 91379 standard. Data type D was designed primarily for names of legal entities and names of products.

datatypeD_1_150

DIN 91379 data type D with 1-150 characters

datatypeE

This data type can only be supported by IT procedures that also support the non-normative characters in the DIN 91379 standard. Data type E was designed for all normative and extended characters of the DIN 91379 standard. This data type can be used for cross-border data exchange if Greek and Cyrillic characters are also required. It therefore represents the technical implementation of the interface agreement “All normative and non-normative characters according to the DIN 91379 standard” (“*Alle nach Norm DIN 91379 normativen und nicht-normativen Schriftzeichen*”). Texts with letters or non-letters that are not included in the DIN 91379 standard, such as Asian or Arabic characters, are not permitted.

isinInternational Securities Identification Number (ISIN):

Two Latin upper case letters, followed by nine upper case letters or numbers, followed by a number

interne_knrInternal identification number:

The internal identification number of investment funds without an ISIN for which a report is to be submitted consists of five digits.

In the case of closed-end investment funds, the internal ID number corresponds to the BBK_INSTITUTS_ID.

bafin_id

Federal Financial Supervisory Authority (BaFin) ID of the company (eight numeric characters) or “unbekannt” (“Unknown”)

leiLegal Entity Identifier:

The legal entity identifier (LEI) is based on ISO standard 17442 and consists of 20 alphanumeric characters. If the LEI is unknown, “unbekannt” (“Unknown”) can be entered.

emailValid email address:

A valid email address in the format “characterstring@characterstring.do” (do = two to four-digit domain name). A personal or functional email address can be entered.

telnrValid telephone number format:

A valid telephone number consists of a sequence of digits. The prefix can optionally be marked with “+” followed by 3 to 39 digits.

bbk:jaNein

“ja” (“yes”) or “nein” (“no”):

The entry “ja” (“yes”) or “nein” (“no”) must always be written in lower case.

3.4.3 Complex data types

bbk:adresse

The data type `bbk:adresse` standardises the general format of companies’ address data. It is used in the elements `<bbk:ERSTELLER>` (creator), `<bbk:ADRESSAT>` (addressee), `<bbk:ABSENDER>` (sender), and `<bbk:MELDER>` (reporter) and contains the following sub-elements:

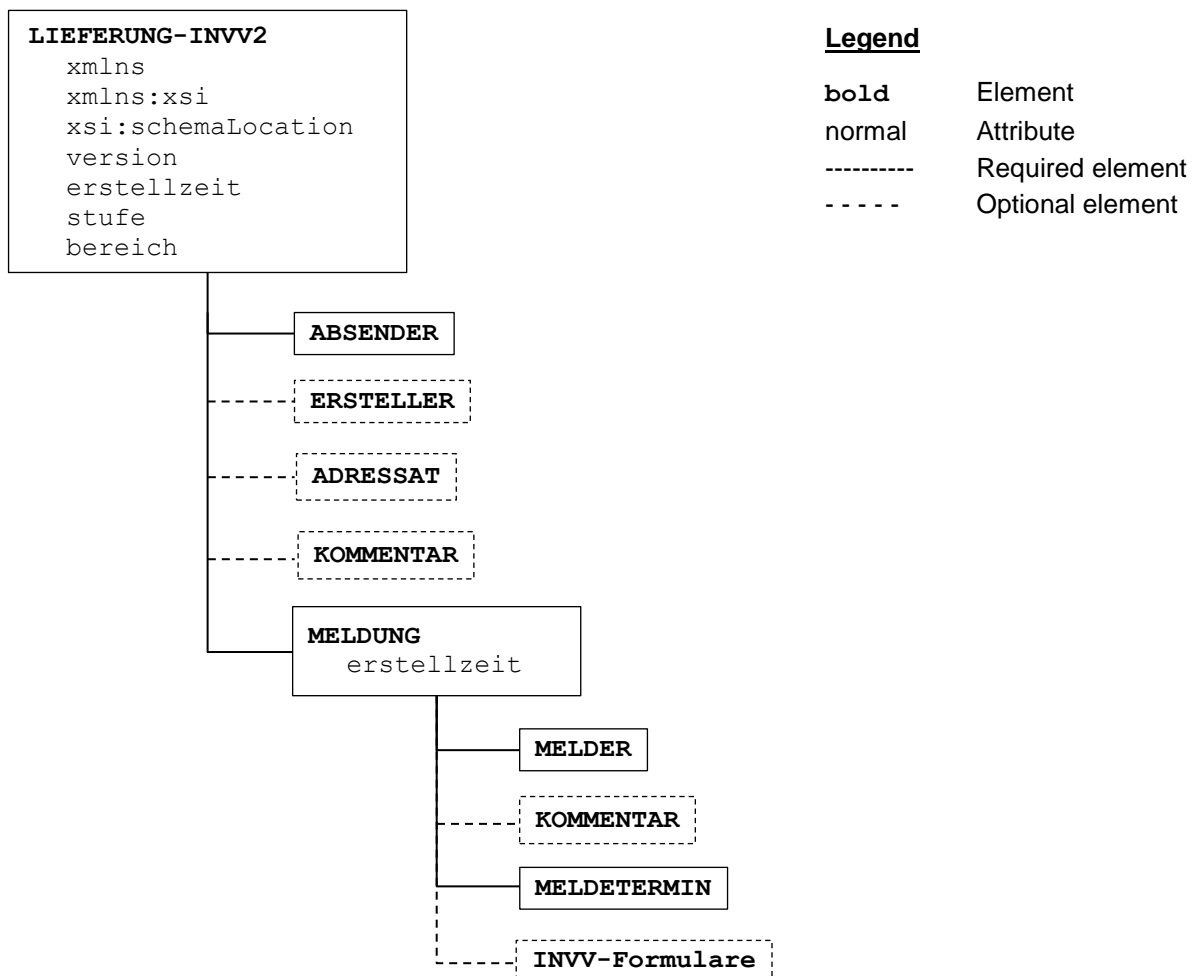

4 InvV report

4.1 Structure of the XML report

All XML files for reporting banking statistics have a common basic hierarchical structure. It begins with a root element containing address information (<LIEFERUNG-INVV2>). It contains a reporting element (<MELDUNG>), which, in turn, contains a form element. The form elements (<InvV-Formulare>) contain reporting data at the lowest hierarchical level.



4.2 LIEFERUNG-INVV2

The root element of an InvV XMW report is the element <LIEFERUNG-INVV2>.

Unless otherwise stated, reports must relate to the status as at the end of the reporting month (last day).

For superordinated funds, reports must be submitted separately for each unit class and for each sub-fund.

In addition to the amount of fund assets, all non-financial and financial asset and liabilities positions – where available – must be stated separately, including their sub-categories according to type, maturity, sector and country.

Information on held securities must be submitted separately for each security (security-for-security reporting system).

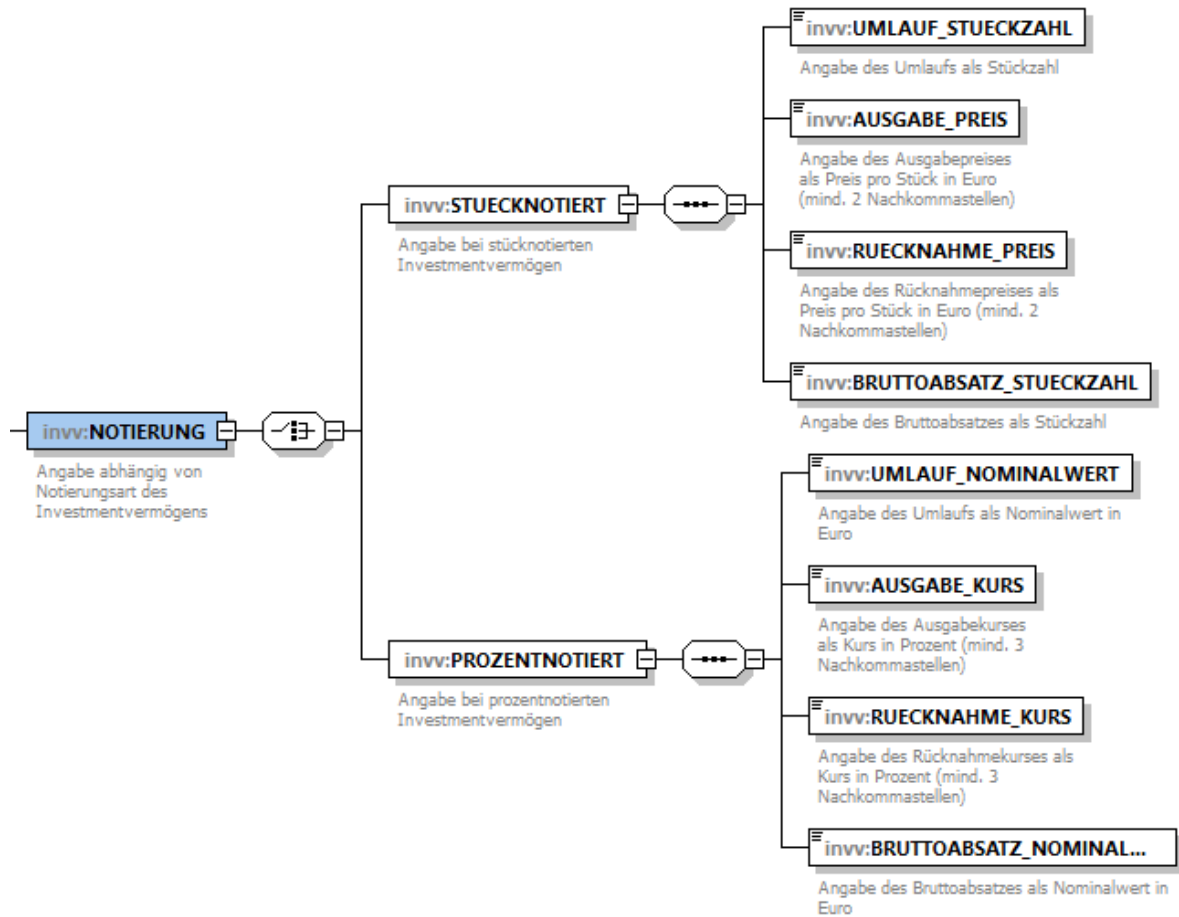
